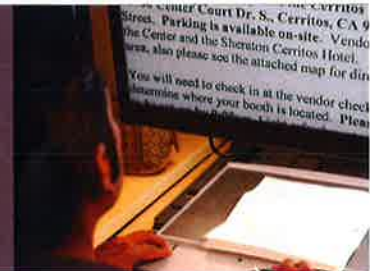

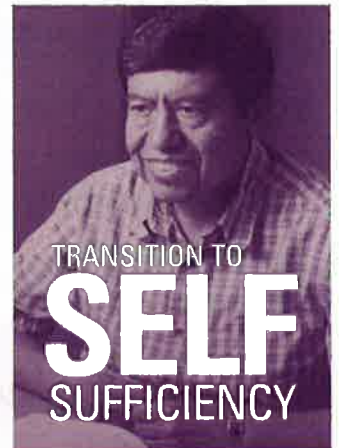
Southern California Rehabilitation Services (SCRS-IL) is a private, non-profit organization dedicated to providing Independent Living and Vocational Services to people with disabilities.

WORK OPPORTUNITY TAX CREDIT (WOTC) is a Federal Tax Credit incentive that Congress provides employers to hire persons with disabilities who consistently face significant barriers to employment. This program enables employees to move from economic dependency to self-sufficiency.

ON-THE-JOB TRAINING FUNDS is an opportunity for consumers to find direct placement in a job and an opportunity for the employer to recover up to \$1,500.00 in training costs through a stipend paid by the Department.
