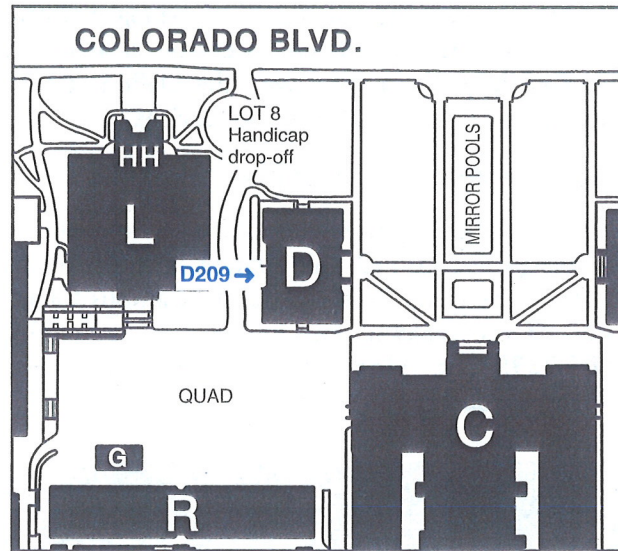

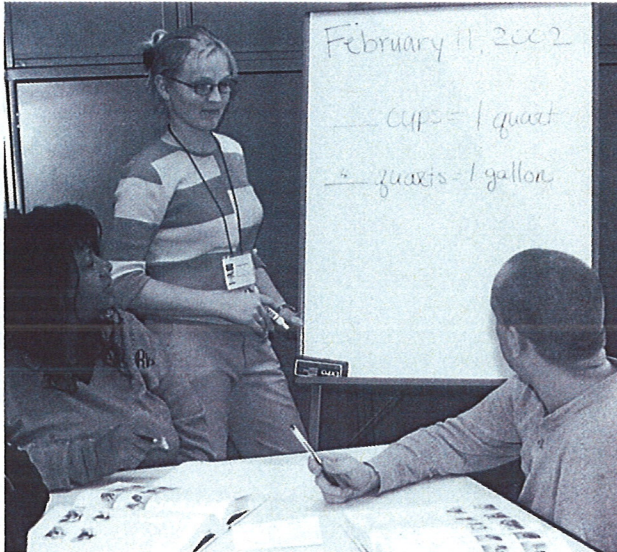

Who is eligible for DSP&S?

Students

- who are deaf or hard-of-hearing
- with visual or physical disabilities
- with speech/language communication disabilities
- with developmental disabilities
- with acquired brain injuries
- with learning disabilities
- with psychological disabilities
- with AD/HD
- with a history of special education services
- with chronic or temporary health concerns

Documentation is required to determine eligibility for services.

If you suspect that you have a learning problem and/or you have not been successful in achieving your goals, you can meet with the DSP&S staff to determine if you are eligible for services.

- Liaison with instructors and with athletics, EOP&S, and Financial Aid offices
- Note takers and readers
- Psychological and AD/HD assessment
- Public TTY access
- Real Time captioning
- Registration assistance and Educational Planning
- Sign language interpreters
- Specialized classes
- Test-taking accommodations
