Funding Allocation Proposals

There are a number of ideas the committee needs to discuss and hopefully prioritize. In addition to the proposals from Special Needs Network and Phoenix Facilitation, Lanterman staff spoke with ClaudiaCares Consulting to learn more of what it does for some of our neighboring regional centers. The Best Practices Subcommittee has also solicited some ideas, which Kristianna Moralls will describe:

- 1. Consider one-on-one coaching that will assist participants and families in understanding the Self Determination Program, identifying Independent Facilitators and Fiscal Management Services, and supporting and encouraging them to move forward until completion. This would require a Request for Proposal.
- 2. Consider the translation of SDP documentation. Need more information as to what documentation would warrant translation.

- 3. Consider paying outright for the cost of Independent Facilitator training for people who are bilingual. That training should include post-training mentoring. This warrants further discussion regarding logistics, cost and selection process.
- 4. Consider training for FDLRC family advocates who want to serve as the Independent Facilitator *only* for their minor child. This training would be simpler than standard IF training because there would be no focus on how to run a business.
- 5. Consider a consultant to develop a support group for parents of Lanterman clients who are transitioning into SDP. This might be modeled on similar efforts at other RCs.
- 6. Consider creating an SDP brochure to be handed out by SCs at each annual meeting with clients; there is an electronic flyer on the FDLRC SDP page which might be a good starting place. Would need to research printing costs.
- 7. Consider contracting with a research consultant to investigate barriers to SDP participation by conducting a focus group of Independent Facilitators who work with the Lanterman RC.
- 8. Does FDLRC need to do a Resource Fair or is it more prudent to promote the Resource Fairs of neighboring regional centers?

Action Recommended

We are recommending that the committee dedicate its June meeting agenda to this topic so as to finalize a plan of action
