APPROVAL OF MINUTES

UPDATE ON SDP DATA ANALYSIS

Mr. Jimenez presented the SDP data analysis on sixty three clients that have been tracked through the Self-Determination process. Twenty-nine individuals from the initial soft rollout have been followed all the way through the process, and have fully transitioned into SDP. Thirty five individuals have requested Self-Determination since the program became available to all; three have fully transitioned into SDP.

Discussion followed and the Committee found value in the information. The Committee recommended that the data should to be compared to the overall Center's population.

Review of Participant Directed Services Position

Mr. Jimenez announced that the Center is looking to hire a Participant Choice Coordinator. The position will oversee the implementation of the Participant Directed Services and will educate clients and families on Participant Directed Services and will ensure that Service Coordinators are properly trained and prepared to handle the requirements of Participant Directed Services. Mr. Jimenez will elaborate on the position at the next meeting.

SDAC MEETING DATES FOR 2021

Although the November meeting was scheduled to go dark, the Committee agreed by consensus to meet on November 4, 2021 and go dark in December.

PUBLIC CONVERSATION

WELCOME AND INTRODUCATIONS

APPROVAL OF MINUTES

The minutes of October 7, 2021 were tabled until February 3, 2022 due to a lack of a quorum.

PRESENTATION OF SDP OMBUDSPERON OFFICE

As part of committee education, Ms. Katie Hornberger, Department of Developmental Services, gave a focused presentation on the Office of the Ombudsperson for Self-Determination. Ms. Hornberger elaborated on what the Ombudsperson does and does not do and how community

members can get assistance. Committee members were given the opportunity to ask questions and discuss the content.

STATEWIDE MEETING REPORT

Mr. Landry gave some brief highlights from the SSDAC meeting on November 10th which focused on updates from DDS (with Nancy Bargmann and Tim Travis), discussion on DDS SDP initiatives, and the introduction of Ombudsperson. This was the first meeting since the July 1st statewide rollout of the Self-Determination Program (SDP) and the local chairs were given the opportunity to share about the difference SDP is making in their respective communities. In lieu of presenting individual member reports, chairs were asked to come prepared to share a Self-Determination success story from their regional center. Mr. Landy was prepared to share a story from Michelle Wolf, but time ran out in the meeting and he was unable to share.

PRESENTATON ON SDP DATA ANALYSIS

Mr. Jimenez presented the Self-Determination Program (SDP) data analysis on seventy-three (73) clients that have been tracked through the SDP process. Twenty-Eight (28) clients are part of the pilot sample and forty-five (45) are newer to the SDP. Forty-one (41) clients have been followed all the way through the process and have fully transitioned into the SDP.

Discussion followed on the demographics and milestones of the 73 clients.

REVIEW OF PARTICIPANT DIRECTED SPECIALIST POSITION

Mr. Manicone announced that the Center is looking to hire a Participant Choice Coordinator. The position will oversee the implementation of the Participant Directed Services and will educate clients and families on Participant Directed Services and will ensure that Service Coordinators are properly trained and prepared to handle the requirements of Participant Directed Services. Mr. Manicone reported that interviews are in the works and the Center hopes to have the position filled by January 2022.

Twenty-Eight (28) clients are part of the pilot sample and fifty-eight (58) are newer to the SDP. Fifty-three (53) clients have been followed all the way through the process and have fully transitioned into the SDP.

Discussion followed on the demographics and milestones of the 86 clients.

REVIEW OF PARTICIPANT DIRECTED SPECIALIST POSITION

Ms. Ruiz was introduced as the Participant Choice Coordinator. The position will oversee the implementation of the Participant Directed Services and will educate clients and families on Participant Directed Services and will ensure that Service Coordinators are properly trained and prepared to handle the requirements of Participant Directed Services.

FUNDING TO SUPPORT IMPLEMENTATION OF THE SELF-DETERMINATION PROGRAM

At the April meeting, the Committee will discuss the remaining balance from the FDLRC 2021-22 allocation to support the implementation of the Self-Determination Program.



A total of 102 clients have been tracked through the Self-Determination process as of March 1, 2022.


- 28 clients are part of the pilot sample
























The Self-Determination Process for All Families

 The next chart shows you the 4 time intervals between each milestone in the 1st half of the Self-Determination process


Time Intervals Between First SDP Milestones
